### **• Réamhrá / Introduction**

Comhlíonann an Polasaí Iontrála seo ceanglais an Achta Oideachais 1998, an Achta Oideachais (Iontráil i Scoileanna) 2018 agus an Achta um Stádas Comhionann 2000. Agus an polasaí seo á dhréachtú, chuaigh bord bainistíochta na scoile i gcomhairle le foireann na scoile, le pátrún na scoile agus le tuismitheoirí leanaí atá ag freastal ar an scoil. *This Admission Policy complies with the requirements of the Education Act 1998, the Education (Admission to Schools) Act 2018 and the Equal Status Act 2000. In drafting this policy, the Board of Management of the school has consulted with school staff, the school patron and with parents of children attending the school.*

D'fhaomh an pátrún scoile an polasaí ar an 15<sup>th</sup> Bealtaine 2020. Tá sé foilsithe ar shuíomh gréasáin na scoile agus cuirfear ar fáil i gcóip chrua é ar iarratas d'aon duine a iarrann é / *The policy was approved by the school patron on 15<sup>th</sup> May 2020. It is published on the school's website and will be made available in hardcopy, on request, to any person who requests it.*

Tá na dátaí agus na hamlínte ábhartha do pholasáí iontrála Gaelscoil Aoinach Urmhumhan leagtha amach san fhógra maidir le hiontráil bhliantúil na scoile a fhoilsítear go bliantúil ar shuíomh gréasáin na scoile seachtain amháin ar a laghad roimh thús an phróisis iontrála don scoilbhliain lena mbaineann / *The relevant dates and timelines for Gaelscoil Aonach Urmhumhan's admission process are set out in the school's annual admission notice which is published annually on the school's website the week of September 23rd, one week before the commencement of the admission process for the school year concerned.*

- **Spiorad saineúil agus cuspóirí ginearálta na scoile / Characteristic spirit and general objectives of the school**

Is Bunscoil Náisiúnta Chaitliceach comhdeachasúil í Gaelscoil Aonach Urmhumhan atá faoi phátrúnacht Easpag Caitliceach Chill Dá Lua. Tá Príomhoide Riarthach, 8 Múinteoirí Ranga, 4 Mhúinteoirí um Oideachas speisialta agus Cúntóir Riachtanais Speisialta ag an nGaelscoil. Freastlaíonn timpeall agus 240 dalta ar an scoil ó Rang Naíonáin Shóisireacha go Rang a 6. *Gaelscoil Aonach Urmhumhan is a Catholic Co-educational National School under the patronage of the Catholic bishop of Killaloe. There is an Administrative Principal, 8 Classroom Teachers, 4 Special Education Teachers and 1 Special Needs Assistant at the Gaelscoil. Approximately 240 children attend the school in classes from Junior Infants to Sixth Class.*

Ciallaíonn “Éiteas Caitliceach” i gcomhthéacs bunscoil Chaitlicigh, éiteas agus spiorad saineúil na hEaglaise Caitlicí Rómhánaí, a bhfuil sé mar aidhm aige forbairt a dhéanamh ar: *'Catholic Ethos' in the context of a Catholic primary school means the ethos and characteristic spirit of the Roman Catholic Church, which aims at promoting:*

- (a) gach gné de phearsa an dalta go hiomlán agus go comhchuí, lena n-áirítear na gnéithe intleachtúla, fisiciúla, cultúrtha, morálta agus spioradálta; agus / *the full and harmonious development of all aspects of the person of the pupil,*
- (b) caidreamh beo le Dia agus le daoine eile / *a living relationship with God and with other people*
- (c) fealsúnacht saoil atá spreagtha ag creideamh i nDia agus i saol, bás agus aiséirí Íosa ; agus / *a philosophy of life inspired by belief in God and in the life, death and resurrection of Jesus*
- (d) múnú na ndaltaí sa chreideamh Caitliceach, the formation of the pupils in the Catholic faith

agus go gcuireann an scoil oideachas reiligiúnach ar fáil do na daltaí de réir theagaisc, chleachtas agus thraidisiúin na hEaglaise Caitlicí Rómhánach, agus / nó éiteas agus / nó spiorad saineúil mar a chinneadh Comhdháil Easpag Éireann ó am go ham.

De réir S.15 (2) (b) den Acht Oideachais, 1998 seasfaidh Bord Bainistíochta *Gaelscoil Aonach Urmhumhan* le, agus beidh sé freagrach don phátrún as seasamh le, sain spioraid na scoile de réir mar a chinntíonn na luachanna agus traidisiúin chultúrtha, oideachasúla, mhorálta, reiligiúnacha, shóisialta, teangeolaíocha agus spioradálta a mhúnláíonn cuspóirí agus meon na scoile.

Tá an Ghaelscoil ag brath ar dheontaisí agus acmhainní na Roinne Oideachais agus Scileanna agus oibríonn an scoil faoina stiúradh. Leanann an scoil na cláracha curaclaim leagtha síos ag an Roinn a bhíonn athruithe ó am go chéile ag comhlíonadh Acht Oideachais 1998, (9), (30). Tacaíonn an scoil leis na prionsabail a leanas: Cuimsitheacht, go mór mór do pháistí le riachtanaisí speisialta, Comhionannas Cead isteach agus Rannphairtíocht ar scoil, Rogha Tuismitheoirí/Caomhnóirí do rollaithe, agus Meas ar éagsúlacht luachanna, creideamh, traidisiúin, agus modhanna maireachtála an tsaoil. *The Gaelscoil depends on the grants and teacher resources, provided by the Department of Education and Skills, and operates under its guidelines. The school follows the curricular programmes prescribed by the Department, which may be amended from time to time, in accordance with sections 9 and 30 of the Education Act (1998). Is scoil í Gaelscoil Aonach Urmhumhan arb é an cuspóir atá aici oideachas a sholáthar i dtimpeallacht a chuireann luachanna reiligiúnacha áirithe chun cinn agus ní dhéanann sí idirdhealú i gcás nuair a dhiúltaíonn sí cead isteach do dhalta nach Caitliceach é/í agus cruthaítear go bhfuil an diúltú riachtanach chun éiteas na scoile a choinneáil.

*Gaelscoil Aonach Urmhumhan is a school whose objective is to provide education in an environment which promotes certain religious values and does not discriminate where it refuses to admit as a student a person who is not of the Catholic faith and it is proved that the refusal is essential to maintain the ethos of the school.*

Is scoil í Gaelscoil Aonach Urmhumhan arb é an cuspóir atá aici oideachas a sholáthar i dtimpeallacht a chuireann luachanna reiligiúnacha áirithe chun cinn agus ní dhéanann sí idirdhealú i gcás dalta a ghlacadh a bhfuil iarratas curtha isteach d'áit sa scoil de réir alt 7A den Acht um Stádas Comhionann. *Gaelscoil Aonach Urmhumhan is a school whose objective is to provide education in an environment which promotes certain religious values and does not discriminate in relation to the admission of a student who has applied for a place in the school in accordance with section 7A of the Equal Status Act 2000.*

*Ba cheart do thuismitheoirí/chaomhnóirí, atá ag iarraidh páiste a chur chuig an nGaelscoil, teagmháil a dhéanamh leis an scoil agus Polasaí Iontrála agus Foirm Iarratais Rollaithe a fháil, chomh luath agus is maith leo. Ní mór do thuismitheoirí/chaomhnóirí daltaí atá ag lorg rollaithe i nGaelscoil Aonach Urmhumhan foirm iarratais rollaithe a líonadh, agus a chur ar ais don scoil ón gcéad lá de Mhí Dheireadh Fomhair an bhliain sula dteastaíonn ón dtuismitheoir(i)/caomhnóir(i) go dtosnóidh an páiste sa scoil. Rachaidh ainm an pháiste ar an liosta rollacháin nuair a fhaigheann an scoil an fhoirm seo ar ais le cóip Theastas Breithe an pháiste. Luíonn an fhreagracht le thuismitheoir(i)/caomhnóir(i) go bhfaigheann an scoil an fhoirm. Beidh Lá Oscailte gach Fomhar / *Prospective parents/guardians can contact the school to receive an Admissions Policy and an Enrolment Application Form, as early as they wish. Enrolment Application Forms will be accepted from the first of October, the year before parent(s)/guardian(s) would like their child to commence school. A child will go on the enrolment list when this completed form is received at the school. Responsibility for the form reaching the school lies with the parent(s)/guardian(s). An Open Day will be held each Autumn.**

*Ligfidh an scoil seo isteach gach dalta atá ag lorg iontrála ach amháin sna cásanna a leanas / This school shall admit each student seeking admission except where:*

(i) I gcás ina bhfuil ró-éileamh ar an scoil (féach ar an alt cuí seo thíos) / *The school is oversubscribed* (see this section below for further details)

(ii) I gcás go dteipeann ar thuismitheoir dalta, nuair a éilíonn an príomhoide é de réir alt 23(4) den Acht Oideachais (Leas) 2000, a dhearbhu i scríbhinn go bhfuil cód iompair na scoile inghlactha dó nó dí agus go ndéanfaidh sé nó sí gach iarracht réasúnach lena chinntiú go gcomhlíonfaidh an dalta an cód sin / *A parent of a student, when required by the principal in accordance with section 23(4) of the Education (Welfare) Act 2000, fails to confirm in writing that the code of behaviour of the school is acceptable to him or her and that he or she shall make all reasonable efforts to ensure compliance with such code by the student.*

Is scoil Chaitliceach í Gaelscoil Aonach Urmhumhan agus féadfaidh sí diúltú glacadh le duine nach dalta de chreideamh Chaitliceach é/í sa chás go gcruthaítear go bhfuil an diúltú riachtanach chun éiteas na scoile a choinneáil. As Gaelscoil Aonach Urmhumhan is a Catholic School, admission can be refused to a pupil of another faith if the pupil will not adhere to the Catholic ethos.

- **Ró-iarratas / Oversubscription**

Sa chás go bhfuil ró-éileamh ar an scoil, déanfaidh an scoil na critéir roghnaithe a leanas a chur i bhfeidhm san ord ina bhfuil siad thíos maidir leis na hiarratais a fhaightear laistigh den amlíne chun iarratais a fháil, mar atá leagtha amach i bhfógra iontrála na scoile agus na hiarratais ar chead isteach á gcinneadh aici / *In the event that the school is oversubscribed, the school will, when deciding on applications for admission, apply the following selection criteria in the order listed below to those applications that are received within the timeline for receipt of applications, as set out in the school's annual admission notice:*

(i) Do pháistí tógtha le Gaeilge (Riail 24 do Bhunscoileanna) / *to children brought up with Irish as their first language (Rule 24 - National Schools)*

(ii) Do pháistí a bhfuil Gaeilge á labhairt ag na thuismitheoir(i)/caomhnóir(i) agus an-suim sa, agus dilseacht don Ghaeilge acu / *to children whose parent(s)/guardian(s) speak Irish and have a specific interest and commitment to Irish*

(iii) Do pháiste le siblín / leathshiblín sa scoil nó a d'fhreastal ar an scoil cheanna, nó a roinneann an seoladh céanna le dalta, nó do pháistí le thuismitheoir/caomhnóir a d'fhreastal ar Ghaelscoil Aonach Urmhumhan, *to a pupil who has a sibling / half sibling attending or who attended the school, a child who lives at the same address as current student, or a child who has a parent/guardian who is a past pupil of Gaelscoil Aonach Urmhumhan,*

(iv) Don pháiste is sine, má tá gach rud eile ar chomhscór / *to the oldest child, if all else is equal*

- **An méid nach mbreithneofar ná nach gcuirfear san áireamh / What will not be considered or taken into account**

De réir alt 62(7)(e) den Acht Oideachais 1998, ní dhéanfaidh an scoil aon cheann díobh seo a leanas a bhreithniú ná a chur san áireamh agus iarratais ar chead isteach á gcinneadh nó nuair a bhíonn dalta á c(h)ur ar liosta feithimh le haghaidh iontrála sa scoil.

*In accordance with section 62(7) (e) of the Education Act, 1998, the school will not consider or take into account any of the following in deciding on applications for admission or when placing a student on a waiting list for admission to the school:*

*A student's prior attendance at a pre-school or pre-school service, including naíonraí, other than in relation to a student's prior attendance at an early intervention class;*

Íocaíocht táillí nó ranníocaíochtaí (cibé slí a dtuairiscítear é) leis an scoil; Gaeilge, de réir fhorálacha alt 62(9) den Acht

*The payment of fees or contributions (howsoever described) to the school;*

Cumas, scileanna nó inniúlacht acadúil an dalta; seachas i ndáil le ligean isteach i scoil

*A student's academic ability, skills or aptitude; other than in relation to admission to an Irish language school, in accordance with the provisions of section 62(9) of the act):*

Gairm, stádas airgeadais, cumas acadúil, scileanna nó inniúlacht tuismitheoirí dalta

*The occupation, financial status, academic ability, skills or aptitude of a student's parents;*

*A student's connection to the school by virtue of a member of his or her family attending or having previously attended the school; (other than, in the case of the school wishing to include a selection criteria based on (1) siblings of a student attending or having attended the school and/or (2) parents of a student having attended the school.
